



**The Commons Act 2006 (Section 19 (2)(a))**

**Application to Correct the Register – Application No. CLD2017/1**

Notice is hereby given that an application has been made by D C Planning Limited on behalf of the applicant, Lewis Wyatt (Construction) Limited to Dorset County Council as Commons Registration Authority, concerning land at **Leigh Common, Colehill, Wimborne**, as shown on the attached plan numbered 2036.

The applicant is applying for the register of common land to be corrected by de-registering those parts of Leigh Common, currently recorded on the register under the register unit number CL1, which coincide with what the applicant believes to be maintainable 'public' highway within the area edged in red on the accompanying plan (2036), on the basis that they ought not to have been registered as common land as it was highway at the time of registration. This being contrary to Section 22(1) of the Commons Registration Act 1965, which defined 'common land' as excluding highways.

The effect of the application, if granted, would lead to the de-registration of any part(s) of the registered common land, found to be 'public' highway, within the area edged in red on the accompanying plan, which forms part of Leigh Common, Colehill, Wimborne, from the register of common land.

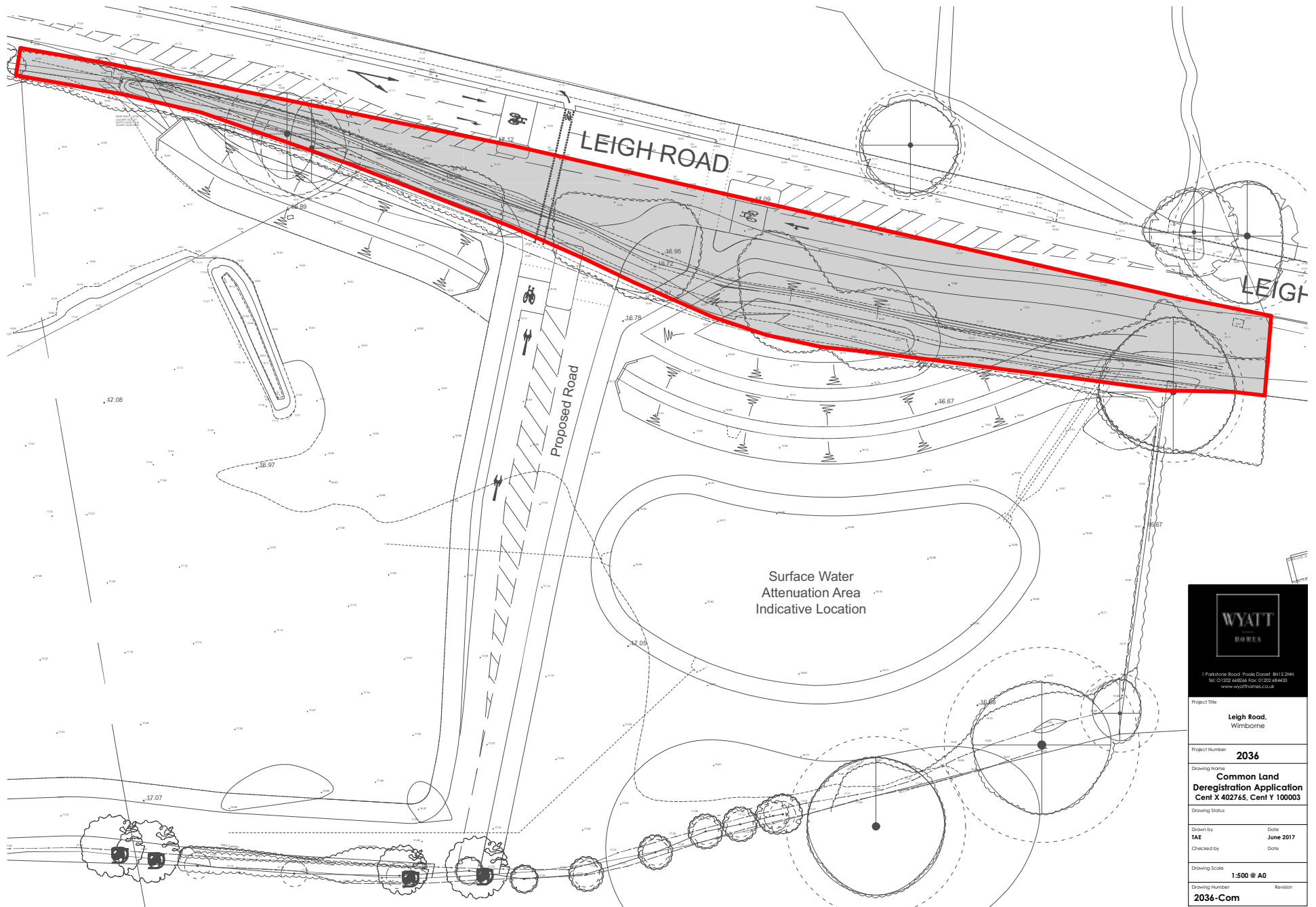
Any representations made in respect of this application cannot be treated as confidential, but will be dealt with in accordance with regulation 25 of the Commons Registration (England) Regulations 2014, and where the application is referred to the Planning Inspectorate for determination in accordance with regulation 26, any representations will be sent to the Planning Inspectorate. **Representations MUST include the following:**

- The Application Number
- The name and postal address of the person making them and the nature of the person's interest, if any, in any of the land affected by the application, and may include an e-mail address
- The grounds on which they are made
- The signature of the person making them
