**Definitive Map and Statement Modification Order 2025**

This Order is made by Dorset Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Dorset Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(c)(i) namely, that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates and section 53(3)(c)(iii) namely, that any other particulars contained in the map and statement require modification.

The authority has consulted with every local authority whose area includes the land to which the Order relates. Dorset Council hereby order that:

1. For the purposes of this Order the relevant date is 13 March 2025.
2. The County of Dorset Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as the "Dorset Council (A Footpath at Second Cliff Walk, West Cliff, West Bay, Bridport) Definitive Map and Statement Modification Order 2025".

## **SCHEDULE**

(The points specified relate to the map attached to the Order, and their positions are identified by national grid references)

### **Part I**

#### **Modification of definitive map Description of path to be added**

##### **Footpath 113, Bridport:**

E-E1-F Commencing at the junction with definitive bridleway W1/105 at point E on West Cliff Road (SY 4583 9066), south-west to point E1 (SY 4577 9059), continuing south-west to point F at the junction with definitive footpath W1/106 (SY 4576 9057).

Width: 3 metres between point E (SY 4583 9066) and point E1 (SY 4577 9059), then narrowing to 1.3 metres to point F (SY 4576 9057).

### **Part II**

#### **Modification of definitive statement Variation of particulars of path**

##### **Footpath 113, Bridport**

##### **Add:**

From: SY 4583 9066 To: SY 4576 9057

Commencing at the junction with definitive bridleway W1/105 at SY 4583 9066 on West Cliff Road, south-west to SY 4577 9059, continuing south-west to the junction with definitive footpath W1/106 at SY 4576 9057.

Width: 3 metres between SY 4583 9066 and SY 4577 9059, then narrowing to 1.3m to SY 4576 9057.

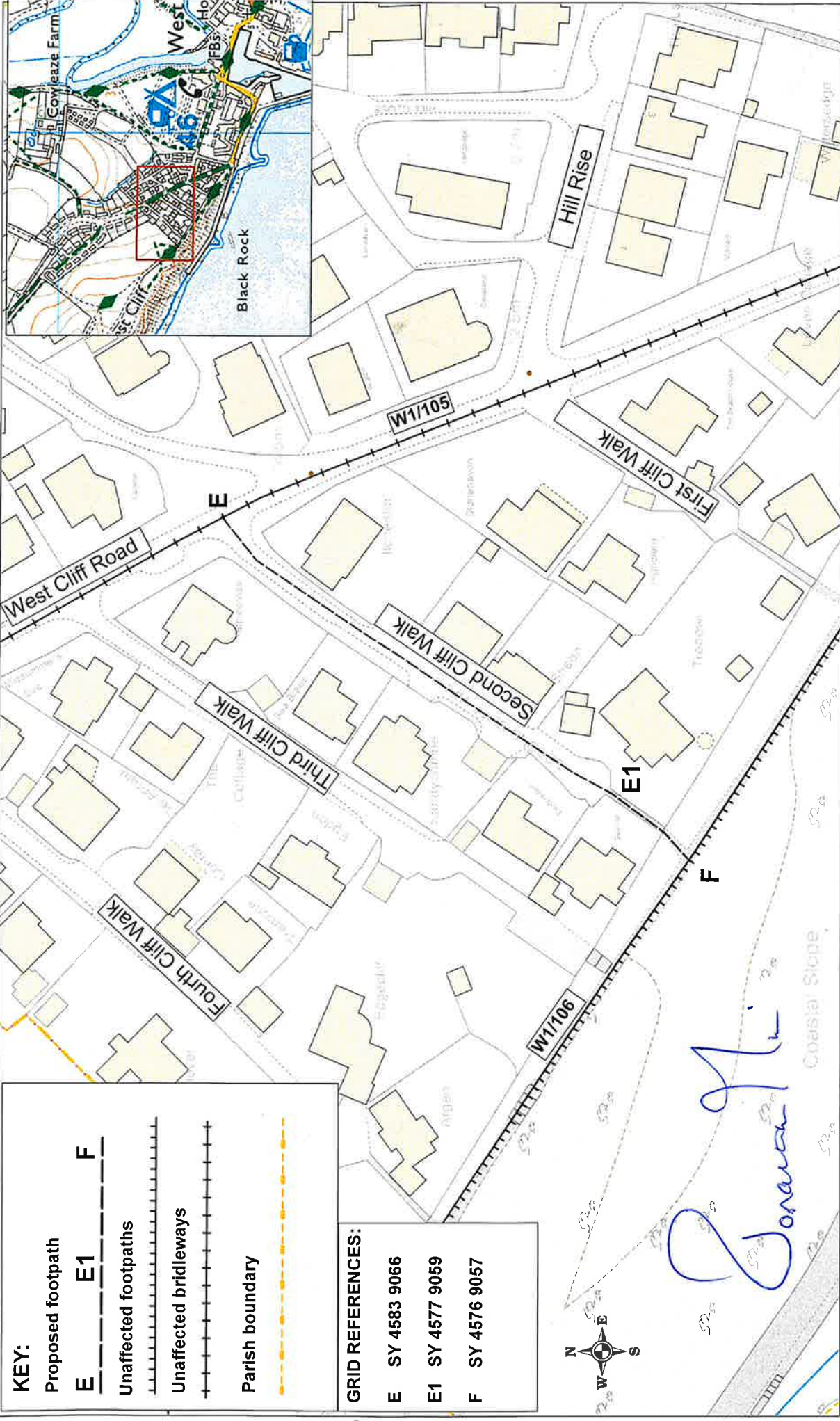
