G-J1-J Commencing at the junction with definitive bridleway W1/105 on West Cliff Road at point G (SY 4585 9060) eastwards to point J1 (SY 4587 9060), continuing eastwards to point J (SY 4595 9058) at the junction with the public road known as Forty Foot Way and definitive footpath W1/24.

Width: 4 metres between point G (SY 4585 9060) and point J1 (SY 4587 9060), widening to 5 metres at point J (SY 4595 9058).
